Drop-off: We can drop trailers in the paddock on Tuesday afternoon after 6 PM.

Registration: The track has asked to complete their waiver in advance. Click on the following image to access Calabogie's on-line waiver:



PCA registration will be open at 7:30 AM or as soon as the Registrar arrives. The PCA waiver will be signed at registration. For those arriving after 8:30 AM, drivers and/or guests, you'll sign the track waiver prior to entering the paddock and our PCA registration will be located at Control. Everybody attending the event (including your guests and family) will be required to wear a wristband to indicate that they have signed the waivers. These will be distributed at registration. PLEASE MAKE SURE THAT EVERYBODY ASSOCIATED WITH YOU SIGNS THE PCA WAIVER AS WELL AS THE TRACK WAIVER. You only need to register on the first day you attend.

Workers: Worker assignments will be done at the track. We will be looking for volunteers to staff Control and maybe staging.

Tech: PLEASE GET INTO THE PADDOCK PROMPTLY - EMPTY YOUR CAR OF ALL LOOSE GEAR AND MATERIALS, APPLY YOUR CAR NUMBERS, AND MOVE QUICKLY TO THE TECH LINE WITH YOUR HELMET AND PRE-TECH FORM. WE ARE TIGHT FOR TIME AND THE TECH LINE CLOSES AT 8:30 AM SO PLEASE BE PROMPT AND GET TO THE TECH LINE QUICKLY. YOUR CAR MUST BE TECHED, YOU WILL NOT BE ALLOWED ON THE TRACK WITHOUT GOING THROUGH THE TECH LINE! You must have your car teched each day. If you are late to Tech, you will be expected to contribute \$20 to NER's charity, Homes for Our Troops.

As always, **every car needs to be pre-teched** as explained in the “Technical Inspection” section mentioned above.

Instructors please note: Although you will be doing your own inspection when you get to the track you are still required to have your vehicle pre-inspected by an appropriate inspector as described in the “Technical Inspection” section of the website. At some events we have had Instructors turning up with Tech forms filled out by themselves or by someone unidentifiable as a PCA tech Inspector. This is contrary to PCA requirements and will not be accepted. If it is not clear to you what is required please email Stan or Aaron in advance of the event so that we can explain it to you. Those failing to meet this requirement cannot be allowed to run under the terms of our insurance.

Noise Restrictions: Calabogie:

15. Noise Restriction: The Client shall be responsible for ensuring its Participants respect the Mandatory Noise Restriction of 92 dB or lesser without exception. This reading will be taken on a full acceleration pass by at a minimum distance of 50 feet. In order to enforce the Mandatory Noise Restriction, CMP will measure noise levels of vehicles and/or equipment prior to being granted access to the track. The sound level shall be measured 5m in front and 5m behind a stationary vehicle with its engine operating at maximum allowable rpm or the red line of the tachometer. For a vehicle to be permitted to use the track the average sound level shall not exceed 100 dBA. At its own discretion, CMP may also conduct noise level testing at various points around the track facilities at various times during the event with its own method of measurement and choice of equipment. The measurements so taken shall be final and binding upon the Client and its Participants, without recourse against CMP or right of contestation.

Sound Check: Every car will also need to complete a sound check and receive a passing sticker. This is a CMP rule. Sound check will be available every morning, but each car only needs to complete this check once. You will be instructed to proceed to sound check after the regular tech inspection.

Two Spin Rule: Any driver who leaves the track (two or four wheels off), spins, is not in control of his/her car, and/or makes contact with another car or object will be black flagged and must come into the pits to have the car looked over and to be queried for the cause. Do not wait for the black flag to come into the pits. A second incident may be cause for not driving the rest of the day and/or ejection from the event.

Attitude Adjustment: Anyone deemed to be unsafe and discourteous will be ejected from the event. Safety is our primary concern throughout the course of the event. This is NOT a timed event and it is NOT practice for racing.

Lunch and Debrief: There will be a classroom each day during lunch and a box lunch will be provided each day, trackside. There will be a debrief when the track goes cold at the end of the first two days (liquid refreshments will be served). These sessions are designed to wrap up the day's events and set goals for the following day.

Fuel: CMP now has fuel available at the track for your convenience – 91 and 94 octanes are available.

Tires: Powersports Garage may be able to help you with your needs (613-316-5841).

Charity Events: We will not be doing Charity Events at this event.

So, study your materials, make sure your car is pre-teched, MAKE SURE YOU PRINT YOUR SCHEDULE and we'll see you at the track,

Calabogie Motorsports Parks - Rules

General Rules

- Calabogie Motorsports Park is open between the hours of 7:30 AM and 7:00 PM on an Event Day.
- Online pre-registration for an event is mandatory.
- Pre-signing of the “Release of Liability Waiver” is mandatory prior to arriving at the track.
- This should have already been provided to you after registration or by the organizing club’s event that you are attending.
- No paper waivers available at the gate.
- Non-participants or guests are welcome to attend the event with you however, they must have signed the same waiver as was sent to you. If they have not signed the waiver, they will be denied access at the gate. No exceptions will be made.
- Fully electric vehicles of any make are not permitted to run on the track as per our insurer.
- No drones permitted at any time. You will be removed from the park if you are found to be flying one.
- Please use the recycle containers under the tent area.
- Do not place flammable items into garbage cans.

Paddock Regulations

- Pets are welcome and must be on a leash at all times.
Note: Pets are not permitted inside any building or washroom.
Please clean up after your pet or you will be asked to leave the park.
- The paddock speed limit is 20km/h at all times. Anyone exceeding that will be removed from the park.
- Fuel is available at the Turn 21 store located in the middle paddock. Both 91 and 94 octane are available at the pumps.
- Race fuel can be ordered in advance with Stinson Fuels by calling 613-623-4207. Fuel will be delivered to you at the park.
- The Turn 21 store carries your favorite Calabogie Motorsports branded apparel along with drinks and snacks.
- Use of car jacks, jack stands or kick stands permitted only when properly protecting the asphalt.
- Oil and coolant waste disposal stations are found at multiple locations throughout the paddock. Refer to the site maps for their specific locations.
- Please take empty fuel tanks, propane tanks, broken parts, engines, tires etc. home with you. These items are not to be left in our garbage cans.

Sound Testing Procedures

We are all guests of the Calabogie community and must adhere to the following limits.

- Sound testing must be completed once per year and each time your exhaust has been modified.
- Stationary test - Sound levels will be measured 15 feet in front and behind the vehicle while the engine is revved at 2/3's of redline of the tachometer.
- For cars the average should be no more than 100 dbA with no single reading over 104 dbA.
- For motorcycles the average should be no more than 98 dbA with no single reading over 100 dbA.
- Pass-by Test - With the vehicle under full acceleration on the track, a reading will be taken from 50 feet. The maximum level allowed is 92 dbA.

If you are found to be unable to meet these limits Powersports Garage may be able to fix any issues onsite and can be found in the lower paddock or at 613-316-5841.

Overnight Stays

If you are an event participant, you can stay the night prior to and during your event in an RV or tent with the following guidelines:

- We do not have any general public camping.
- No arrivals before 5pm the day before your event.
- Some events will require later arrival times and those will be communicated by your event organizer prior to your event.
- You will have 2 hours after your event concludes to vacate the facility.
- Quiet time is between 8:00 PM and 7:30 AM, this includes loud music and generators.
- No open fires or fireworks.
- No tent pegs into the pavement.

Track Walks

- Track walks after 7:00 PM are permitted, but please be aware track staff may still be performing maintenance or clean-up.
- You may walk, run, bicycle, skateboard or rollerskate. Absolutely no golf carts, scooters, or motorized vehicles of any kind are permitted after 7:00 PM. You will be fined and removed from the park, no exceptions.
